

BUDWEISER SWEEPSTAKES® - OFFICIAL RULES

1. No Purchase Necessary. 6. All prizes will be awarded (time permitting). Odds of winning depend upon the number of eligible entries received. The potential winner will be notified by phone, text or email and will be required to respond to the notification within twenty-four (24) hours indicating whether he/she can accept the prize. If no response is received within the time allotted, an alternate potential winner will be randomly selected (time permitting). Any alternate potential winner selected will also be required to respond to the notification within twenty-four (24) hours.
