

**BUD LIGHT – EASY TO DRINK. EASY TO ENJOY. EASY TO FILL SWEEPSTAKES ®  
UNIVERSITY OF FLORIDA - OFFICIAL RULES**

1. No Purchase Necessary. The **“BUD LIGHT EASY TO DRINK. EASY TO ENJOY.
